Public comment may be submitted in writing prior to the meeting or orally during the meeting.

- *Electronic Writing* – Written comments may be submitted via email to jhaupt@sonomalibrary.org. Written comments will be provided to Commissioners and added to the record. Put the agenda item number, if known, in the subject line of the email. Email comments must be received at least one (1) hour prior to the start of the meeting.
- *U.S. Mail* – Written comments may be submitted via U.S. mail to Healdsburg Library, ATTN: LAB Comments, 139 Piper Street, Healdsburg, CA 95448. It is advised you consider normal delays in mail delivery when sending your written comment via U.S. mail.
- *Orally, Live* – Oral comments may be given during the meeting.
- *Orally, Via Zoom* – Oral comments may be given during the meeting through the computer. Members of the public wishing to provide live public comment in this manner must call 1-707-308-3224, so that they can be provided with the Zoom meeting information and participation instructions.
